Further Delays to EES

The EU's new Entry/Exit System (*EES*), which has faced multiple delays due to technical challenges and concerns from member states is now facing further setbacks. In a recent interview with KentOnline news, Doug Bannister, Chief Executive of the Port of Dover, stated that the system is now not expected to be introduced until November 2025.

The EES aims to enhance border security by electronically recording the entry and exit of non-EU travellers, replacing the traditional passport stamping method. This system will require non-EU citizens to register biometric information, such as fingerprints and facial images, upon their first entry into the Schengen Area and every subsequent three years.

However, the implementation has been postponed several times since its planned launch in 2021. While some ports and airports are prepared, others lack the necessary facilities, leading to concerns about potential long queues at entry points such as Dover and Eurostar's St Pancras terminal.

The European Commission is now considering a phased or "ultra-soft launch" later in 2025 to prevent severe disruptions and is expected to announce more details by May.

Once operational, the EES will be followed by the introduction of the European Travel Information and Authorization System (ETIAS), which will require travellers from 60 countries, including the UK, to apply for authorisation to enter 30 European countries. The ETIAS is slated to launch 6 months after the EES.
